9: 30: Meeting minutes were reviewed, modified and approved.

9:40 PM: Agenda items were discussed as the following:

1: Dialogue Dinner on June 6th

- Discussion: date is not certain, intrafaith group is going to organize the event and discuss more.
- Board vote: all in favor

2: Attorney payment

-Most recent payment was a couple weeks ago, it was 2,000 monthly. The remaining balance was 13,000.

- Recent donation amounts were discussed at this time.

3: Summer camp and subsidizing summer camp fees as needed

- Ferruh Y. discussed the importance of all students attending camp and to support those that may have financial need.
- Berkta O. spoke for the education committee about summer camp assistance
- 7500 was allocated to the education committee
 - o So far 1000 has been spend.
 - o Camps are being planned for this summer
 - o Estimated 5000 to spend on summer camps this summer

- Sky Academy
- Four different groups going to summer camp
- The education committee would like to help up to 1/3 of the price for families that cannot to afford it. If more is needed, then it can be discussed with each family on a need basis.
- The board discussed how we would cover the summer camp cost.
 - Have the parents pay their portion of the cost and the TCC will cover the rest of the costs.
- 22 students from upstate NY are
- Jafer Y. expressed concerns over official policies in place that ensure the summer camp costs will not go over budget and that we could adjust our bylaws accordingly.
- The Board agrees to cover 1/3 of the fees for students that need/ask for assistance.

4: Keeping track of activity volunteers (Activity records)

 - Approx. cost 1000
 - 120 people attended
 - 10 volunteers
 - 50 hour volunteer work
- Outside praying & picnic
 - April 11 was the first picnic of the season
 - Approx. cost 1000
 - 100 -120 people attended
 - 10 volunteers
 - 50 hour volunteer work
- Ramadan food boxes
 - 75-100 hours
 - 25 days
 - 40 boxes each day
 - Approx. cost n/a (all donations-400 each day)
- Donations
 - Hand sanitizer to other charities
 - 10 additional charities received donations
 - 2 -3 volunteers
 - 2 hours each volunteer
- Spring Camp
 - Approx. cost 1000

- 180 hours

Ferruh Y. explained that Menduh E. concerns were being examined and improvements needed to be made

Ramazan A. stated that some audits did not need to be done because the TCC has no employees.

Menduh E. stated that new board members should received a summary of board activities in both English in Turkish.

Jafer Y. stated that typically there is a training for new members.

The discussion brought up the importance of understanding the interworkings of Non-Profits.
